Investment Objective

The Loftus Peak Global Disruption ETF (**ASX Code: LPGD**) aims to deliver a return over the Benchmark MSCI All Countries World Index (net) (as expressed in AUD from Bloomberg) over the medium to long term by bringing a disciplined process to investment in global listed disruptive companies.

Reasons to consider LPGD

- ▶ Simple, one ticker access to a high performing portfolio of global disruptive businesses.
- ▶ Exposure to megatrends such as 5G, the cloud, digitisation, decarbonisation/electrification, gene editing and more.
- ▶ Diversification across a wide range of industries and geographies, lowering the concentration risk and home bias in the typical domestic portfolio.

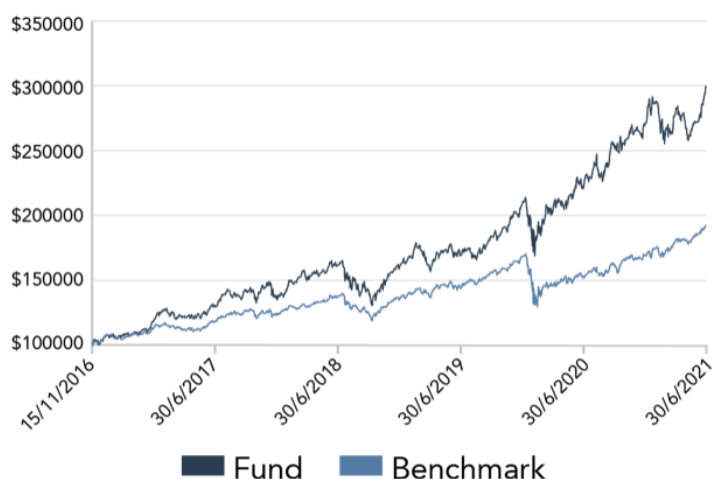
